# FEDERAL EDUCATION POLICYMAKERS, 1941 - 2009

This outline of key legislators, administration officials, and education policy actions by the federal government is a product of the States' Impact on Federal Education Policy Project (SIFEPP), a national initiative led by the New York State Archives and funded by The New York Community Trust – Wallace Foundation Special Projects Fund. **Historical Note:** The federal Office of Education was created on March 2, 1867. It became part of the Department of the Interior on July 1, 1889. As of July 1, 1939 it was placed under the Federal Security Agency of the Department of the Interior where it remained until the creation of the Department of Health, Education and Welfare (HEW) in 1953. The Commissioner of Education reported directly to the Secretary of HEW until 1972 when an Education Division was created, headed by the Assistant Secretary for Education. The Office of the Commissioner of Education ceased to exist when the Department of Education was created in 1980.
