aforesaid are yet unknown, being Subjects of this State of New York not having the
Fear of God in their Hearts, nor weighing the Duty of their Allegiance, but being
moved and seduced by the Instigation of the Devil and as false Traitors against
this State of New York withdrawing that cordial love and true and due Obedience
Allegiance and Fidelity which every Subject of this State towards this State ought
of Right to bear and designing and with all their might traitorously intending
the Government and Constitution of this State now duly and happily established
to change and subvert and the People of this State of their Empire and Government
thereof to deprive and the People of this State to the Dominion Tyranny & Oppression
of George the third King of Great Britain then and as yet an Enemy to and at
open War with the People of this State to reduce and bring and intending to aid
and adhere to the said King of Great Britain in the said War and to move raise
and levy War and Rebellion within this State against the People of this State on
the twentieth day of June in the Year of our Lord one thousand seven hundred and
eighty and at divers other days and Times as well before as after at the District
of Half Moon — in the County aforesaid with force and arms falsely Maliciously
and Traitorously did publicly adhere to the King of Great Britain then and as yet
the Enemy of and at open War with the People of this State, and did meet propose
consult conspire and agree to go to the Province of Quebec then and as yet a Province
of and within the Dominions and in the Power of the King of Great Britain then
and as yet the Enemy of and at open War with the People of this State and to
adhere to, aid and abet the Inhabitants of the said Province then and as yet
Subjects of the said King of Great Britain and then and as yet Enemies of and
at open War with the People of this State in the said War, And that the said
William Johnson and the other Persons as aforesaid yet unknown for the more
effectual completing and effecting their said Treasons and Traitorous Intentions on the said
twentieth — day of June in the Year aforesaid did at the District of Half Moon in
the County aforesaid with force and arms March go and proceed towards the Province
of Quebec aforesaid with such wicked and Traitorous Intention of going to the said
Province and of adhering to, aiding and abetting the Inhabitants thereof as aforesaid.
And that the said William Johnson and the other Persons aforesaid as yet unknown for
the more effectual completing and effecting their said Treasons & Traitorous Intentions
on the said twentieth — day of June in the Year aforesaid at the District aforesaid
in the County aforesaid, being armed and arrayed in a warlike and Hostile manner
with Swords Guns and divers other Weapons as well offensive as defensive with
force and arms did falsely and Traitorously assemble and join themselves against
the People of this State, and then and there with force and arms did falsely and
Traitorously and in a warlike and Hostile manner array and dispose themselves
against the People of this State and then and there with force and arms in pursuance
of such their wicked and Traitorous Intentions and Purposes aforesaid did falsely and
Traitorously prepare order wage and levy a public War against the People of this State
against the Duty of their Allegiance, and against the Peace of the People of this
State and their Dignity
