FISHER, LEON, Sergeant.

Enlisted at Fort Slocum, N. Y., December 9, 1917, and assigned to Medical Department. Sailed January 22, 1918, and arrived at Le Havre, France, February 9, 1918. Member Company F, 101st Infantry, 29th Division, Medical Department. (First Aid). Appointed First Aid Sergeant August 29, 1918. Discharged at Camp Upton, N. Y., April 21, 1919.

GOLDSMITH, FRANK LEE, Private.

Enlisted at Elmira, N. Y., June 11, 1917, and was sworn into the service June 15, 1917, at Marine Training Station at Paris Island, South Carolina, and assigned to Drill Company E, 45th U. S. Marines. Transferred to Marine Training Camp at Quantico, Virginia, August, 25, 1917. Sailed from Philadelphia, Penn., October 25, 1917, arriving in Brest, France, November 12, 1917. Transferred to 97th Company, 6th Regiment Marines Infantry, 2d Division, August 26, 1917, and remained in that contingent until March 7, 1918, in hospital at Camp No. 3, Bourmont, France, with measles; Base 2, — Vittel, and Base 8 at Savenay, France, with tuberculosis, from March 7, 1918, to April 20, 1918, when he sailed for the United States, arriving May 12, 1918. In hospitals in United States from May 12, 1918 to December 24, 1918, at Newport News; Waynesville, South Carolina; Norfolk, Virginia; Fort Lyons, Colorado. Discharged from United States Naval Hospital at Fort Lyons, Colorado, December 24, 1918.



HOPKINS, FREW, 2d Radio Electrician.

Enlisted at Brooklyn Navy Yard, December 7, 1917, and served at Newport, Rhode Island, Training Station; Cambridge, Mass., Radio School; Aviation Camp, Pensacola, Florida, and Philadelphia, Penn. Discharged at League Island Navy Yard at Philadelphia, Penn., February 18, 1918.



LARSEN, LARS, Private, 1st Class.

Enlisted at Geneva, N. Y., November 5, 1917. Sent to Fort Slocum, N. Y., and assigned to 4th Recruit Company. Transferred to Fort McKinley, and assigned to 12th Company, and later to Battery C, 54th Artillery, Coast Artillery Corps. Sailed from Portland, Maine, March 22, 1918, and arrived at Le Havre, France, April 2, 1918. May 20, 1918, assigned to 2d Battery, Howitzer Regiment, Coast Artillery Corps. August 15, assigned to 44th Artillery, Battery F, Coast Artillery Corps. Defensive and counter-offensive on Champagne Front, near Laval, France, July 15 to 24, 1918; an attack near Baccones, France, July 27, 1918; St. Mihiel offensive, September 12, 1918; offensive near Lake La Chaussee, France, November 9 to 11, 1918. Discharged at Fort Totten, N. Y., February 15, 1919.
